1. Apologies

2. Notes and Actions from 5th meeting on 29 January 2018

- There were no changes to the notes.
- As Carolyn Taylor had yet to attend a meeting of the group it was agreed to contact her to see if she still wished to be involved, perhaps with a project in the summer involving the school.

- KD outlined the 3 criteria necessary for designating a TPO (appended to the
 previous minutes). The group agreed that there were notable trees in the Parish
 that would not qualify, but nonetheless, should still be recorded. The Scots Pine
 in Church Close and Weeping Birch in Bridge St. were mentioned in addition to
 those listed at the last meeting.
- JB had planted a sapling Small-leaved Lime (*Tilia cordata*) at the recreation ground.
- It was agreed to create a list of notable trees on Dropbox.
- These would also be added to the site map
- KD drew attention to a Suffolk Flora Preservation Trust publication "Barons to Botanists: Landholders & Land-use on two Suffolk Nature Reserves" which included factors to take into account when advising landowners on managing grassland. KD would add the relevant section to the minutes.

JB reported that he had rescued 35 primrose plants uprooted by ditch clearance at a local farm and transplanted them to the woodland area at the recreation ground.

JB reported that Suffolk Coastal and Suffolk Wildlife Trust had agreed in principle to designate some of the verges of Tiggins Lane as Conservation Verges. He will meet representatives from both organisations in April to identify the best sections for designation.

KD requested a copy of the criteria used for designation. Action: JB

JXB reported a Mistle Thrush feeding on Mistletoe berries, a dead Barn Owl (to be sent for analysis) and a Red Kite, all seen in the village recently.

Appendix: Bat species recorded in Kelsale-cum-Carlton

Serotine (*Eptesicus serotinus*), Natterer's Bat (*Myotis natterei*), Pipistrelle (*Pipistrellus*) (probably also includes the newly separated Soprano Pipistrelle (*Pipistrellus pygmaeus*)) Brown Long-eared Bat (*Plecotus auritus*).

Appendix: Management of Environmentally Important Grassland:

Management prescriptions for the environmentally important grassland meadows are precise:

- Manage the sward by grazing to achieve a sward height between 5 cm and 15 cm during April and May (unless the land has been shut for hay) and between 5 cm and 15 cm in November. The sward should be varied with scattered areas of taller vegetation and taller tussocks.
- Supplementary feeding is confined to the feeding of mineral blocks/licks. Feeding sites should be placed away from areas of archaeological interest.
- Do not cut hay or silage before 30 June, always leaving at least 10% uncut in any one year (which need not be the same 10% each year). All cuttings must be removed.
- Do not roll or harrow more than 30% of the total grassland area in any one year, and always leave a minimum of 5% tussocks / longer grass.
- Ploughing, subsurface cultivation and reseeding are not permitted. Topping, chain harrowing and rolling are permitted except between 15 March and 15 July.
- Field operations and stocking must not damage the soil structure or cause heavy poaching. Small areas of bare ground up to 5% of the field are acceptable.
- Do not apply fertilizer, organic manures or waste materials (including sewage sludge) unless specifically agreed in writing with your Natural England contact.
- Control undesirable species such as creeping thistle, spear thistle, curled dock, broad-leaved dock, common ragwort, common nettle so that their cover is less than 5% of the area.
- Do not install new drainage or modify existing drainage systems.
- Maximum permitted stocking level is 1.5 LU per hectare.
